

Letter of Authorization

Grantor: Beijing Impossible Technology Co.,Ltd (hereinafter called "Party A")

Grantee: Hong Kong Riverside Culture Limited (hereinafter called "Party B")

This Letter of Authorization serves as a supplementary document to the "Authorized Content License Agreement" (hereinafter referred to as the "Agreement") entered into by and between Party A and Party B on [January 1,2026].

3. All rights not expressly granted to Party B under this Agreement shall be retained by Party A.
4. Term of Authorization: Refer to the "List of Authorized Content".

Party A warrants that it has legally obtained the authorization for the authorized content and that the granted rights do not infringe upon the legitimate rights and interests of any third party. If this warranty is breached, Party A shall bear full responsibility for all consequent liabilities.
